- **Housing – Veronica Vaughn**
 - CABHI/MH4R Grant is in the 2nd quarter of its 2nd year. As of today 301 have been served and assisted with housing placement whether it was permanent or temporary.
 - There were 54 individual/families served in the first quarter October – December 2015.
 - The CMHC Providers are starting to enter into SAMHSA Database called SAIS of the GPRA Assessment Tool. The GPRA Assessment Tools were being collected by paper and now each provider has access for entry and should be up to date by the 2nd week in February 2016.
 - DMH and MS Home Corporation are continuing to work together to get the CHOICE program up and running. By the end of this week individuals will be enrolled in the CHOICE program and assisted with housing vouchers in our coastal area (JACKSON, HARRISON, HANCOCK COUNTY)
 - DMH continues to work with MUTEH (MS UNITED TO END HOMELESSNESS) in the use of their AWARDS Database for data collection and reporting of the CHOICE Vouchers.
