State Plan Amendment (SPA) 19-0011 Preadmission Screening and Annual Resident Review (PASRR) in Nursing Facilities (NF) is being submitted to allow the Division of Medicaid to replace the term "mental retardation" with "intellectual and developmental disability (IDD)", effective July 1, 2019.

The Division of Medicaid is revising the State Plan to be in compliance with 42 C.F.R. § 400.203 and Public Law 111-256, "Rosa's Law".

There is no economic impact associated with the submittal of this SPA.
