Pursuant to 42 C.F.R. Section 447.205, public notice is hereby given for the submission of a Medicaid State Plan Amendment (SPA) 19-0023 Private Duty Nursing (PDN). The Division of Medicaid, in the Office of the Governor, will submit this proposed SPA to the Centers for Medicare and Medicaid Services (CMS) effective October 1, 2019, contingent upon approval from CMS, our Transmittal #19-0023.

- 1. State Plan Amendment (SPA) 19-0023 Private Duty Nursing (PDN) is being submitted to add coverage and reimbursement of PDN services for Early and Periodic Screening, Diagnosis and Treatment (EPSDT)-eligible beneficiaries to the State Plan, effective October 1, 2019.
- 2. The expected annual aggregate savings is \$7,735,087. The PDN rate was calculated by adding to the 2019 National Bureau of Labor Statistics (BLS) Annual mean wage for the applicable occupation title for the state of Mississippi to the total of the Federal Insurance Contributions Act (FICA) percentage of 7.65% and an administrative allowance of 7.60%. The savings was calculated by using state fiscal year (SFY)18 data for the number of units billed for PDN services multiplied by the PDN rate which results in a savings of federal dollars of \$5,954,470 for FFY20 and FFY21 and a savings of state dollars of \$1,335,462 for FFY20 and \$1,780,617 in for FFY21.
- 3. The Division of Medicaid is submitting this proposed SPA to be in compliance with 42 C.F.R. § 447.201 which requires that the State Plan describe the policy and the methods to be used in setting payment rates for each type of service included in the State's Medicaid program.
- 4. A copy of the proposed SPA will be available in each county health department office and in the Department of Human Services office in Issaquena County for review.
