

PUBLIC NOTICE

June 16, 2022

Pursuant to 42 C.F.R. Section 447.205, public notice is hereby given for the submission of a Medicaid State Plan Amendment (SPA) 22-0001 COVID Testing. The Division of Medicaid, in the Office of the Governor, will submit this proposed SPA to the Centers for Medicare and Medicaid Services (CMS) effective March 11, 2021, contingent upon approval from CMS, our Transmittal #22-0001.

1. Mississippi Medicaid 22-0001 COVID Testing reimburses for COVID tests according to the current State Plan payment methodology for the service provided.
2. The expected annual aggregate expenditures in Federal dollars for Federal Fiscal Year (FFY) 2022 is \$14,774, 651 and for FFY 2023 is \$13,612,050. The expected annual aggregate expenditures in State dollars for State Fiscal Year (SFY) 2022 is \$2,708,074 and for SFY23 is \$3,870,675.
3. The Division of Medicaid is submitting this proposed SPA to be in compliance with the American Rescue Plan (ARP).
4. A copy of the proposed SPA will be available in each county health department office and in the Department of Human Services office in Issaquena County for review. 6. A public hearing on this SPA will not be held.
