Updating Provider Group Affiliation

ACS Provider Enrollment requires an individual who leaves a group or facility to contact our office to close the affiliation with that group or facility. Banking information, Medicare crossover information, tax information, billing and servicing address information must be verified and updated, as necessary. Your assistance in this process will expedite the correct processing and payment of claims to both the individual and the group. If the necessary information is not updated, claims and payments may be processed incorrectly, which is difficult to reverse. Local Code W9127 Discontinued

Effective April 1, 2003, the Division of Medicaid (DOM) will discontinue use of local code W9127 (medical procedure performed on victim of rape or incest, including necessary reports). The elimination of this code is consistent with HIPAA requirements that will prohibit the use of local codes by payer sources. Providers should report the CPT Evaluation and Management code which identifies the level of service provided to the beneficiary along with the appropriate ICD-9 diagnosis code.
