Correction of Third Party Payment and PPOs Article

In the March 2003 Mississippi Medicaid Bulletin, there is an error in the Third Party Payment and PPOs article on Page 4. The last paragraph, second sentence that begins "If payment is received," should read, "If **no** payment is received, enter zero in the third party field."

Additions, Deletions and Description Changes To the 2003 HCPCS and CPT Codes

The additions, deletions and description changes to the 2003 HCPCS and CPT codes will be loaded into the Medicaid Management Information System (MMIS) in the near future. The 2002 codes should be utilized until the Division of Medicaid (DOM) provides further directions for filing the 2003 codes.

HCPCS Code J7302 To Open April 1, 2003

Effective April 1, 2003, the Division of Medicaid will open HCPCS code J7302 for coverage of Mirena. The description of the code is "Levonorgestrel-releasing intrauterine contraceptive system, 52 mg". The Medicaid allowable will be \$391.05.

The Time Is Near For The New Windows-Based Claims Submission Software

The wait is almost over for the new Windows-based claims submission software. As mentioned in previous bulletins, all current NECS submitters will be transitioning to the new Windows-based claims submission software called WINASAP2000.

Provider Enrollment Now Available Via the Web

Effective March 31, 2003, the provider application and agreement became available online. You can download them for printing and completion, or you can complete the application online and submit it electronically. Completing the forms via the web is easier, more convenient, and less paperwork. The website tailors the application process uniquely to each provider based on individual or group and provider types. The website address is <u>http://msmedicaid.acs-inc.com</u>.

Every Mississippi Medicaid provider is required to re-enroll by completing the newly revised provider application and agreement or completing an online application as detailed above.

Provider re-enrollment is necessary to meet Health Insurance Portability and Accountability Act (HIPAA) requirements. It will also enable the Division of Medicaid to update provider information for the new provider database that is being developed as part of the renovated Medicaid claims processing system for HIPAA compliance. The renovated system is called *Envision*.



Important things to know about provider re-enrollment:

- Every provider must re-enroll regardless of date previously enrolled.
- Re-enrollment must be done by May 31, 2003. Provider numbers will be closed for providers who do not re-enroll.
- Current provider numbers will have a zero (0) added to the beginning of the provider number.

If you had claims paid as late as 2002, enrollment agreement and application forms were mailed to your service address beginning March 31, 2003. Medicaid providers with no activity for 2002 can access enrollment agreement and application forms via the web. If you do not have web access, you can contact ACS Provider Enrollment at 1-800-884-3222 or 601-206-3000 Monday through Friday, 8 a.m.-5 p.m.

- Complete the application online and submit it electronically
- Complete paper enrollment forms
