

ANALYSIS DESCRIBING AWARD, RENEWAL OR AMENDMENT OF CONTRACT

DOM issued IFB #20180511 on May 11, 2018, for qualified contractors to develop, administer, and operate a Non-Emergency Transportation (NET) brokerage program for eligible Medicaid beneficiaries. DOM received three (3) sealed bids from Medical Transportation Management, Inc. (MTM), LogistiCare Solutions, LLC, and Southeastrans, Inc. As a result, evaluations were performed, and DOM acquired approval from the Mississippi Public Procurement Review Board (PPRB) to award the contract to MTM on September 5, 2018.

The overall period of performance for the contract, to include the second (2) renewal option, is October 1, 2018, through September 30, 2023. Per the terms of the contract, DOM has chosen to exercise the option for year two (2) renewal period associated with this contract. With a significant increase to the number of Medicaid beneficiaries eligible to utilize NET services because of the federal declared Public Health Emergency in response to the COVID-19 pandemic, DOM has amended the Contract to update unit pricing in order to address this increase. Compensation for services shall remain a firm and fixed-rate, although the total value may fluctuate based on the number of beneficiaries per month.

The total contract award amount is not to exceed \$156,720,628.10.
