Pursuant to 42 C.F.R. Section 447.205, public notice is hereby given for the submission of a Medicaid State Plan Amendment (SPA) 23-0002 Autism Spectrum Disorder (ASD) Services Rate Update. The Division of Medicaid, in the Office of the Governor, will submit this proposed SPA to the Centers for Medicare and Medicaid Services (CMS) effective January 1, 2023, contingent upon approval from CMS, our Transmittal #23-0002.

- 1. Mississippi Medicaid State Plan Amendment (SPA) 23-0002 Autism Spectrum Disorder Rate Update is being submitted to allow the Division of Medicaid (DOM) to update reimbursement for autism spectrum disorder services to the lesser of the usual and customary charge or a fee from a statewide uniform fee schedule. Fee schedule rates are calculated based on the greater of a rate calculated by an actuarial firm or the rate in effect as of January 1, 2022, effective January 1, 2023.
- 2. The expected annual aggregate increase in expenditures as a result of this SPA is \$156,266. This estimate was calculated by applying the proposed rate updates to calendar year 2021 utilization data.
- 3. The Division of Medicaid is submitting this proposed SPA to be in compliance with 42 C.F.R. § 447.201 which requires all policy and methods used in setting payment rates for services be included in the State Plan.
- 4. A copy of the proposed SPA will be available in each county health department office and in the Department of Human Services office in Issaquena County for review.
