In accordance with PPRB OPSCR Rules and Regulations, Section 5.3.4.2 — Timeliness, this memorandum documents the Division of Medicaid's (DOM) determination that a reasonable period was provided for all potential bidders to prepare and submit bids for the External Medical Review Consulting solicitation. When amendments are issued less than 14 calendar days prior to a bid submission deadline, the agency must make a written determination that the allotted time is reasonable under the circumstances.

The solicitation was posted on the DOM website on October 31, 2025, with an original bid submission deadline of December 12, 2025, providing 31 calendar days for preparation and submission. All solicitation materials, including Amendments 1 and 2, were posted on November 26, 2025, ensuring public access to the complete and current documents.

During the solicitation period, DOM discovered that one bidder did not receive courtesy email notifications for Amendments 1 and 2 due to administrative oversight. To address this, on December 9, 2025, DOM issued:

- Amendment 1 and Amendment 2 to the affected bidder; and
- Amendment 3, extending the solicitation timeline, to all bidders.

Although all amendment documents were properly posted on November 26 and available on the DOM website, DOM extended the bid submission deadline by one week, from December 12, 2025 to December 19, 2025 to allow affected bidder more time to respond. Because the amendments were issued on December 9, the period between issuance and the new deadline was two (2) calendar days shy of the 14-day minimum.

Given the scope and level of effort required for this relatively small procurement, and in the interest of fairness and equal opportunity, DOM determined that the additional 7-calendar-day extension provided sufficient time for the affected bidder to review all amendments, incorporate any necessary adjustments, and finalize their bid submission. Also, DOM did not receive any notification indicating that the time allotted for response was insufficient.

## **Recommendation**

Upon review of the remaining four submitted bids, Physio Solutions dba medlitix submitted the lowest responsive and responsible bid. As presented in the bid, Physio Solutions dba medlitix is a qualified, experienced, and responsible entity that can provide independent external medical reviews for State Fair Hearings and/or State Administrative Hearings for a contract period of March 9, 2026 – March 8, 2029, with one optional two-year renewal. The contract value for the initial period shall not exceed \$225,000.

DOM Office of Procurement recommends that IFB #20251031, External Medical Review Consulting contract be awarded as follows:

**Debriefing Request**

A successful or unsuccessful Offeror may request a post-award debriefing, in writing, in accordance with *Public Procurement Review Board Office of Personal Service Contract Review Rules and Regulations* (PPRB OPSCR Rules) 5.6.2, Debriefings. DOM will schedule and conduct debriefings consistent with PPRB Rules 5.6.2. An Offeror's debriefing is an informal meeting and not a hearing; therefore, legal representation is not required. If an Offeror prefers to have legal representation present, the Offeror must notify DOM and identify its attorney(s) in its written debriefing request in order to allow DOM to also have legal representation present for the debriefing. DOM will conduct all debriefings electronically via Microsoft Teams. A copy of the Debriefing Summary will be made available to the Offeror with whom the debriefing is held within two (2) business days of the meeting. Offerors seeking a debriefing are asked to include potential meeting times with their request.

**Reconsideration of the Intent to Award**

Pursuant to PPRB OPSCR Rules 5.6.3, Reconsideration of the Intent to Award request must be submitted in writing to the DOM Chief Procurement Officer **and** the Department of Finance and Administration Director of the Office of Personal Service Contract Review within three (3) business days following issuance date of the Notice of Intent to Award.
